# Data Privacy Policy

#### What Information do we collect?

We collect information from you when you fill out a form on our website where you will be asked to enter your name, contact details and previous work experience (personal data). The Global Operations & Resourcing Manager is the Controller of the Data. You may however visit our website anonymously.

#### Our legal basis for processing for the personal data

- To meet the contractual obligations entered into by you the customer, data subject and work seekers.
- Purposes of legitimate interests pursued by the controller in order to provide contract work for applicants.
- Processing is necessary to comply with the legal obligation of the controller.
- Consent given by you, the data subject and work seekers.

#### What do we use your information for?

- To personalize your experience (your information helps us to better respond to your individual needs).

- Your information whether public or private, will not be sold, exchanged, transferred or given to any other
  company for any reason whatsoever, without your consent, and will be kept safe at Indicomm with the express

# What do we do with your personal data?

By completing the contact form on our Website it is understood that data subjects are actively soliciting contact from Indicomm Global Ltd about services which match the data subjects' field of interest. Your personal data will be only be used by Indicomm Global Ltd to contact you regarding your enquiry.

## **Information Submitted by You**

We will use information supplied by you to aid the recruitment process and associated administrative functions. We will process any data which you provide in completing the online application forms and any further forms, assessments or personal details which you complete or provide to us when using the Website in accordance with relevant data protection legislation.

## Your rights

At any point whilst we are in possession of or processing your personal data, you, the data subject and work seekers, have the following rights:

- Right of access you have the right to request a copy of the information that we hold about you.
- Right of rectification you have a right to correct data that we hold about you that is inaccurate or incomplete.
- Right to be forgotten in certain circumstances you can ask for the data we hold about you to be erased from our records.
- Right to restriction of processing where certain conditions apply to have a right to restrict the processing.
- Right of portability you have the right to have the data we hold about you transferred to another organisation.
- Right to object you have the right to object to certain types of processing such as direct marketing.
- Right to object to automated processing, including profiling you also have the right to be subject to the legal
  effects of automated processing or profiling.
- Right to judicial review: in the event that Indicomm Global Ltd refuses your request under rights of access, we
  will provide you with a reason as to why. You have the right to complain to the Information Commissioner's
  Office (ICO): www.ico.org.uk.

We do not sell, trade, or otherwise transfer to outside parties your personal data. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising or other uses.
